

League Policies and Procedures

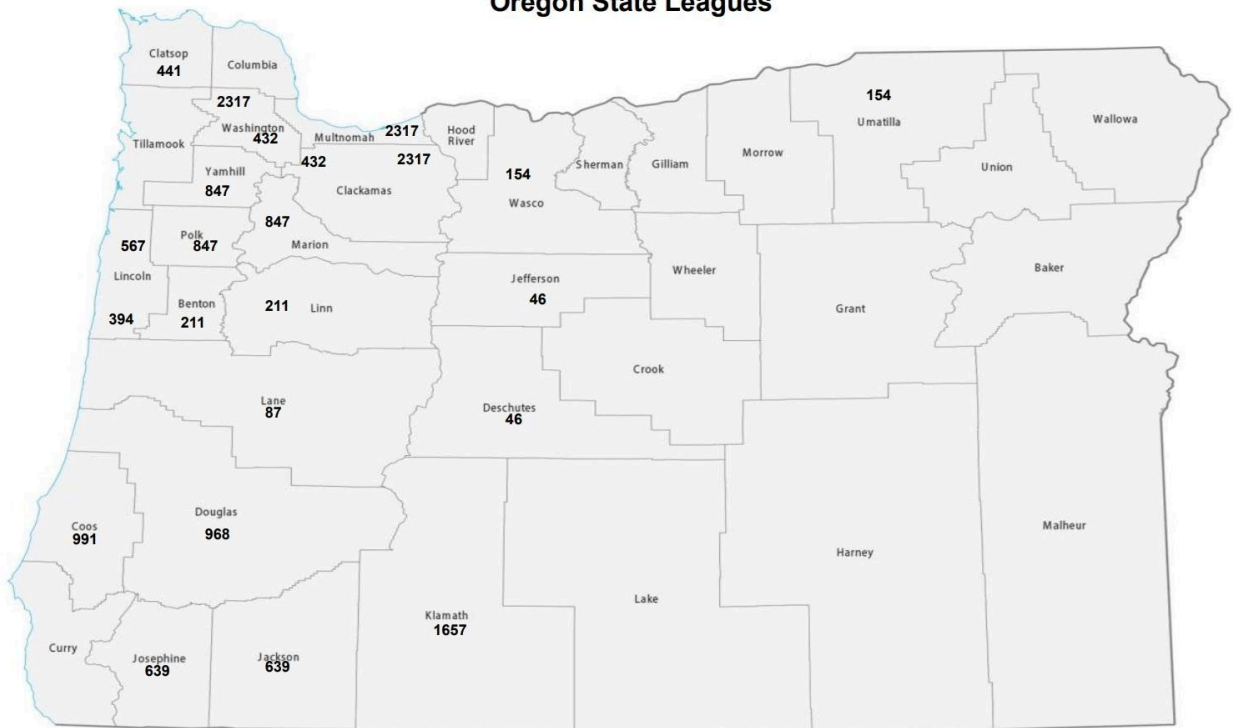
Western BCA Leagues are already bound to the terms of BCAPL policies for becoming a league. All of those policies must continue to be met. There are other policies and procedures within Western BCA that are also required to remain a member of Western BCA.

1. Western BCA Leagues must re-sanction their league annually.
2. Leagues must collect and send a \$15 annual fee to the Western BCA Treasurer for each player in their league within five weeks of commencing a new league session. If a player plays more than one league session in a year the \$15 will be waived or if it was paid a second time in error, the league can request a refund. Fees are required for all players with two or more weeks played.
3. All league sessions must start and end in the same calendar year.
4. All leagues must use LMS to record the stats from league play.
5. **In order to be considered qualified for events such as the Western BCA Regionals, players must have played either a minimum of 8 calendar weeks in a regularly scheduled Western BCA sanctioned league session between January 1st and December 31st of the year prior or players in the current year must have played a minimum of 8 calendar weeks in a regularly scheduled Western BCA sanctioned league session before the tournament entry deadline (usually five weeks prior to the event).** League Operators may request an exemption for the 8 weeks of play in a session if the League Operator feels there are extenuating circumstances. The player would request the exemption in writing to their League Operator. If the League Operator feels the request is valid, the request would be forwarded to the Tournament Registrar. The Tournament Registrar makes note of the request and sends it on to the Board of Directors for approval. When the Board rules on the request it is returned to the Tournament Registrar who returns the request to the League Operator with the results of the request. The League Operator must inform the player of the results of the request.
6. A League's Home Base is defined as, where the League Operator operates their leagues from. This area is normally defined as counties, however, some divisions may cross over county lines depending on their geographical locations.
7. A League's divisions must be within their own state unless there are no other leagues in the area requesting to be a division.

8. Divisions outside of a League's Home Base that currently exist as of February 1, 2025 can continue to operate their established divisions, however, no other divisions will be added into a league that is not within the League's Home Base guidelines without the neighboring League Operator's consent.
9. Divisions Outside the US - Divisions may form in Canada as long as they are within 200 miles of the leagues home base. Canadian Divisions must be no more than 50% of the Home Base's League total membership of the prior years membership total. Example: If there are 100 members of the Home Base's League, the Division in Canada can only have 50 members.
10. New Leagues requesting sanctioning with the Western BCA must:
 1. Contact Western BCA about existing leagues in their proposed area to ensure location(s), night(s) or the potential reduction of existing league players will not infringe on any existing Western BCA league operations. (Current league area descriptions can be found on the attached area maps)
 2. Have a minimum of thirty players. Leagues with less than thirty players may be considered on a case by case basis with approval by the Board of Directors.
 3. Complete and submit the Western BCA's League Sanctioning Agreement.
11. New Leagues requesting sanctioning will be reviewed by the Board of Directors for approval/disapproval, providing the new leagues home base is located in OR, WA, ID, NV, or MT. New leagues outside of the approved states must be reviewed for approval/disapproval by the Board of Directors and ratified by the voting membership. For any approval/disapproval, the League Administrator or President of the Western BCA will notify the requesting League Operator. Renewal applications are to be reviewed and approved by the League Administrator or President. Any decline of renewal application from the President or League Administrator requires Board of Directors review and approval, and ratification from the voting membership.
12. Leagues, once sanctioned, must pay a \$15 player fee to the Western BCA for all players in their league.
13. Newly sanctioned leagues must acquire BCAPL sanctioning within 180 days of membership approval or their Western BCA sanction will be terminated.

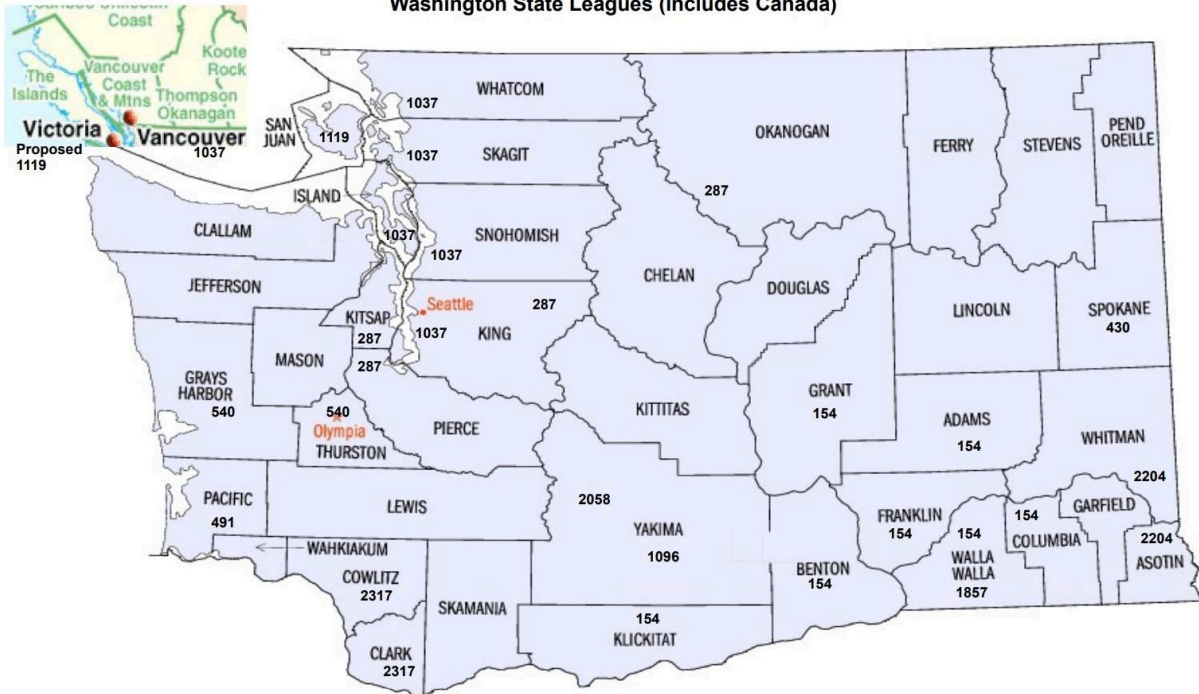

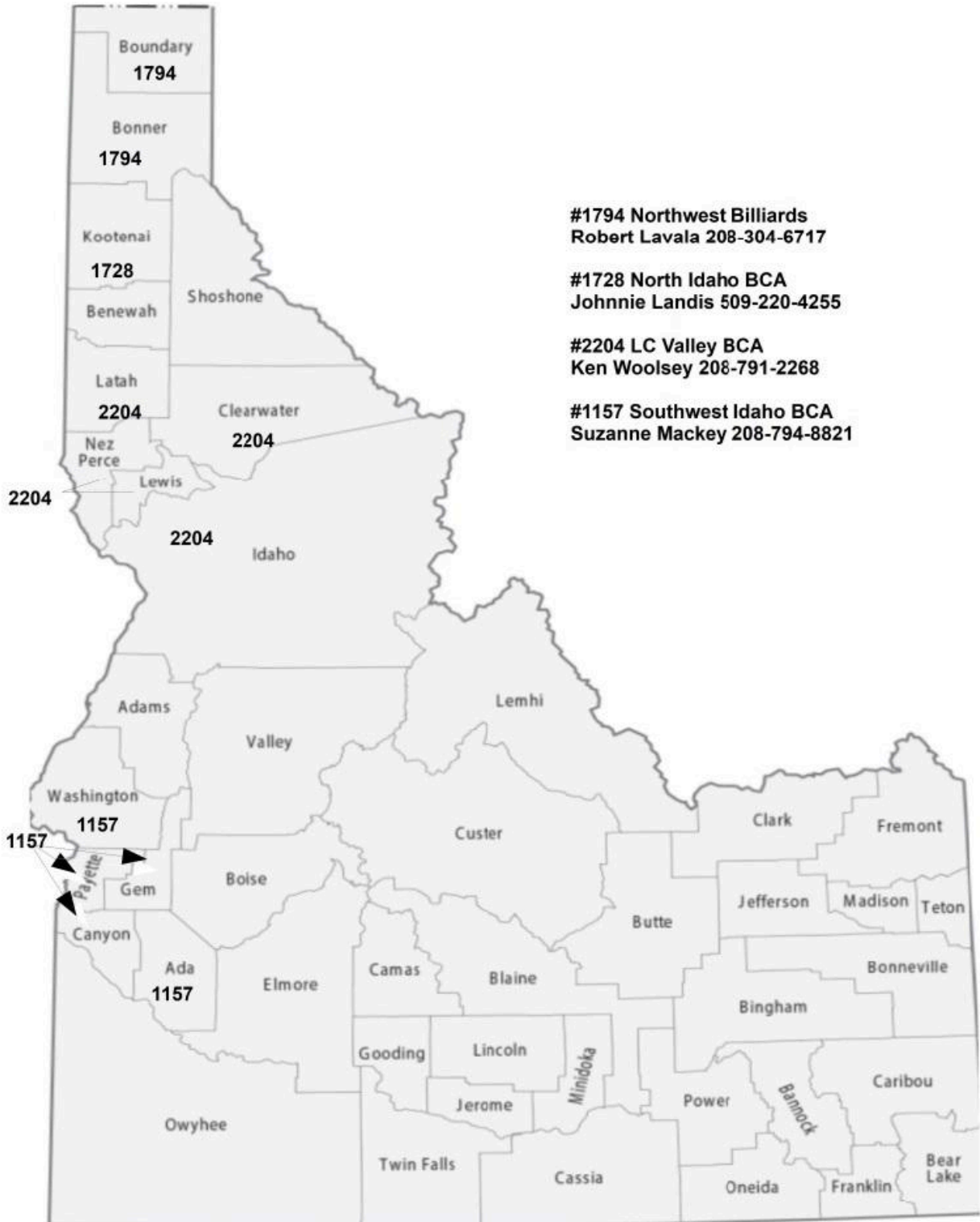

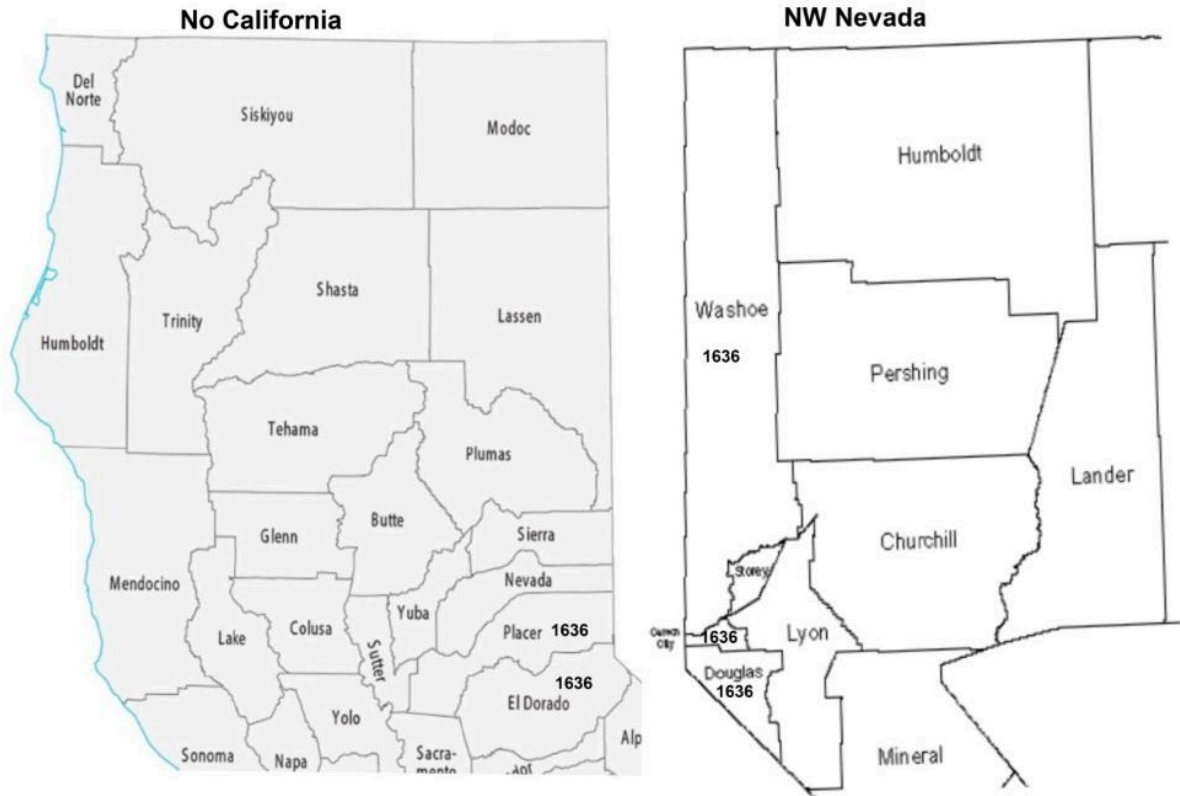
