1. Reviewed and Positively Impacted Overall WBCA & Tournament Financials

- i) Negotiated Long-Term Table and Tournament Direction Contract.

 Led efforts on securing a new table and tournament direction agreement, transitioning from a per-player/per-division model (\$5.00 per person and \$50.00 per division) to a firm fixed-rate contract. This four-year deal provides cost predictability and long-term savings, especially with increasing participation, significantly benefiting WBCA's financial planning and sustainability. This initiative also strengthened our relationship with the tournament direction team therefore improving communication and teamwork both within the WBCA and
- ii) Implemented \$5.00 Administrative Fee to Strengthen Funding
 Proposed and successfully passed a \$5.00 administrative fee to help offset
 rising tournament costs. This change generated approximately \$12,000 in
 additional revenue without impacting prize funds or membership fees allowing
 WBCA to offer larger payouts while also reinforcing financial stability.
- iii) Raised \$15,000 Through Sponsorship Committee Efforts

 Actively contributed to raising around \$15,000 in sponsorship, fully covering streaming costs and enhancing the overall prize fund. These efforts boosted event visibility and value while reducing the financial burden on the association.

2. Tournament Direction & Table Contract (4-Year Agreement)

Led efforts to secure a long-term contract for tournament direction and tables, resulting in substantial cost savings for the organization over a four-year period. This initiative not only strengthened our relationship with the tournament direction team
